- 1 year license suspension beginning 3/25/18
- 3 years of probation with drug counseling and monthly progress reports provided directly to the board, random drug screens, (blood or urine) at his costs to begin on signature date of the consent agreement.
- Mr. Neal may apply for reinstatement after 3/26/2019 and successful ongoing compliance with terms of the consent agreement.

Regina Gillispie seconded. Motion carried. The board instructed staff to prepare the consent agreement and Attorney General's office approve prior to board official signature.

SB288 – Eliminating Funeral Board and placing operations under Secretary of State. (Passed)

HB4597 - Relating to the procedure to determine if an occupation or profession should be regulated. (Died in Judiciary 2/19/18)

HB – CNA's delivery of meds in nursing facilities. Discussion ensued. It is officially noted that this board was not consulted nor involved, and this could be potentially dangerous for our most vulnerable citizens.
